The equipment is a communication headset for integration in helmet.

It consists of one or two loudspeakers in plastic housing with mounting clip, a flexible microphone or bone conductive microphone and a PCB linked by wires to a connector for external connection.

SPECIFIC CONDITIONS OF USE: YES as shown below:

- The intrinsically safe apparatus shall only be connected to intrinsically safe equipment certified for the intended use. This association shall comply with the requirements of the standard IEC 60079-25.
